1. A Rabies Certificate & Negative Coggins must either be presented at all shows or a copy must be on file at the secretary booth before a horse will be allowed to enter any classes at a show. The horse's name on the Rabies Certificate & Coggins must match the registered name registered with the club.
2. All horse owners, riders and horses shown must be registered with the club prior to showing for points to accumulate.
3. If an applicant is under 18 years of age as of January 1st of the current year a copy of his/her birth certificate must be provided to the Membership Secretary within thirty days of application for membership. If this is not received points will not count and the membership will not be valid.
4. **A Junior Member (under 18 years of age as of January 1st of the current year) may become a member only if a parent or legal guardian is also a member in good standing.**
5. If a change of name or address occurs, the Membership Secretary shall receive written notice of such change within two weeks from date of change.
6. If a horse is sold or leased by a member to another member, the Membership Secretary shall receive written notice within two weeks of the date of the transaction. A copy of the bill of sale or lease shall accompany the notice so that any points accrued by the horse can be credited to that horse for the year end awards.
7. **Attendance at two membership meetings and 3 shows is required to qualify for year-end awards. Both the exhibitor (or parent if a youth exhibitor) and the owner of the horse must make the two meeting requirement. YOU MUST MAKE YOUR TWO MEETING REQUIREMENT NO LATER THAN THE SEPTEMBER MEETING.**
8. All members should receive a membership card within two weeks of applying for membership. If you do not receive your membership card please contact Karen.
9. There will be a \$20 fee for any returned check along with any applicable bank charges.
